ROUTES OF EXPOSURE:

INHALATION: Excessive inhalation may produce symptoms of central nervous system depression, ranging from light-headedness, nausea and vomiting, to unconsciousness and death.

INGESTION: May cause irritation of the gastrointestinal tract with vomiting. If vomiting results in aspiration, chemical pneumonia may follow. Absorption through the gastrointestinal tract may produce symptoms of central nervous system depression ranging

light headedness to unconsciousness.

EFFECTS OF OVEREXPOSURE:

ACCUTE: Excessive inhalation or ingestion may produce symptoms of central nervous system depression ranging from light headedness, to unconsciousness and death. Overexposure may result in liver and kidney damage. Exposure of the eyes and skin may produce irritation. Animals exposed to high levels have shown cardiac sensitization.

CHRONIC: Can cause headache, mental confusion, depression, fatigue, loss of sense of balance, and visual disturbances. Prolonged or repeated skin contact may cause dermatitis.
